This Order supersedes Order No. 206287, which was generated internally but not issued publicly.

Notice is hereby given that the Director of Public Works will hold a remote public hearing via teleconference on Monday, April 25<sup>th</sup>, 2022, commencing at 5:30 PM to consider the following:

Removal of twenty-one (21) street trees with replacement as noted below on the 900 to 1100 blocks of Market St., between 5<sup>th</sup> to 8<sup>th</sup> Streets. This is part of Better Market Street – Phase I.

Fifteen (15) of the trees are in poor condition and do not conflict with the proposed work. Six (6) trees conflict with new infrastructure alignments and utility placement.

## **Project Description**

Scope of Work: along Market Street from 5th Street to 8th Street; consists of sidewalk & roadway paving work, sewer & drainage work, water work, AWSS work, traffic & pedestrian signal work, overhead contact system (OCS) work, environmental work, landscape & site improvements, structural sub-sidewalk basement work, traffic routing, and all associated work. Tree removal permit application no. 789335.

- Removal of one (1) street tree at 900 Market Street (Site 8) with replacement.
- Removal of one (1) street tree at 923 Market Street (Site 2) with replacement.
- Removal of two (2) street trees at 929 Market Street (Site 1, 4) with replacement.
- Removal of one (1) street tree at 951 Market Street (Site 13) with replacement.
- Removal of one (1) street tree at 979 Market Street (Site 2) with replacement.
- Removal of one (1) street tree at 988 Market Street (Site 7) without replacement.
- Removal of two (2) street trees at 1000 Market Street (Site 2, 6) with replacement.
- Removal of two (2) street trees at 1005 Market Street (Site 1, 2) without replacement.
- Removal of one (1) street tree at 1066 Market Street (Site 1) with replacement.
- Removal of one (1) street tree at 1083 Market Street (Site 1) with replacement.
- Removal of one (1) street tree at 1119 Market Street (Site 1) with replacement.
- Removal of one (1) street tree at 1127 Market Street (Site 2) with replacement.
- Removal of one (1) street tree at 1133 Market Street (Site 1) without replacement.
- Removal of three (3) street trees at 1155 Market Street (Site 2, 3, 4). Tree 2 & 4 with replacement, Tree 3 without replacement.
- Removal of one (1) street tree at 1160 X Market Street (Site 4) with replacement.
- Removal of one (1) street tree at 1170 Market Street (Site 1) with replacement.

In accordance with numerous local and State proclamations, orders and supplemental directions regarding the COVID-19 virus, Public Works hearings are held through videoconferencing and will provide for remote public comment.
